- (ii) to monitor the implementation of the provisions of the Act, and the rules and regulations made there under and make suitable recommendations relating thereto, to the National Assisted Reproductive Technology and Surrogacy Board;
- (iii) to send such consolidated reports as may be prescribed, in respect of the various activities undertaken in the State under the Act, to the National Assisted Reproductive Technology and Surrogacy Board and the Central Government; and
- (iv) such other functions as may be prescribed.
