No.26/01/2022-M : In exercise of the powers conferred by section 26 of the Surrogacy (Regulation) Act, 2021, the Governor of Manipur is pleased to constitute the **State Assisted Reproductive Technology and Surrogacy Board** for the State of Manipur with immediate effect to discharge the following functions :

- (i) To review the activities of the appropriate authorities functioning in the State and recommend appropriate action against them.
- (ii) To monitor the implementation of the provisions of the Act, and the rules and regulations made thereunder and make suitable recommendations relating thereto, to the Board.
- (iii) To send such consolidated reports as may be prescribed, in respect of the various activities undertaken in the State under the Act, to the Board and the Central Government; and
- (iv) Such other functions as may be prescribed.
