ORDER:

In the circumstances reported by the Commissioner, Health & Family Welfare, AP., in the reference 2nd read above, Government have decided to constitute the District Medical Board for Surrogacy.

2. Accordingly, in view of the Explanation under section 4 (3) (a) (1) of the Surrogacy (Regulation) Act, 2021, Government hereby constitute the District Medical Board for Surrogacy consisting with the following members:-

District Medical Board for Surrogacy:

| Sl. No. | Officer | Designation |

| a | The District Medical and Health Officer | Chairman/Chairperson |
| b | HoD of Gynaecology and OBG Department(nominated by the Dist.Collector & DM&HO) | Members |
| c | HoD of Paediatric Department(nominated by the Dist.Collector & DM&HO) | Members |

Terms and conditions:

1. The Districts Medical Board shall meet once in a month.
2. Even though the intervening period of each meeting shall be one month, depending upon the situation, necessity and during emergency arises, the special meeting shall be convened by the authority.

Functions :

- a) District Medical Board issue a certificate of a medical indication in favour of either or both members of the intending couple or intending woman necessitating gestational surrogacy.
- b) such other powers as may be prescribed by the State Board for surrogacy or Central Board for surrogacy.
