8.	Shri Micheal K. Sangma, Adil Gandhian Society, Tura	Member
9.	Secretary, Health & Family Welfare Department	Member-Secretary

The Terms of Reference of the Committee are as follows:-

- (i) to review the activities of the appropriate authorities functioning in the State and recommend appropriate action against them;
- (ii) to monitor the implementation of the provisions of the Act, and the rules and regulations made thereunder and make suitable recommendations relating thereto to the Board;
- (iii) to send such consolidated reports as may be prescribed, in respect of the various activities undertaken in the State under the Act to the Board and Central Government; and
- (iv) such other functions as may be prescribed.
