

- to review the activities of the appropriate authorities functioning in the State and recommend appropriate action against them;
- to monitor the implementation of the provisions of the Act, and the rules and regulations made thereunder and make suitable recommendations relating thereto, to the Board;
- to send such consolidated reports as may be prescribed, in respect of the various activities undertaken in the State under the Act, to the Board and the Central Government; and
- such other functions as may be prescribed.

2. The term of office of a member other than ex-officio is given under Clause 28 of the Surrogacy (Regulation) Act, 2021.



3. Other terms and conditions of the Board are given under Clause 29, 31, 32, 33 and 34 of the Surrogacy (Regulation) Act, 2021.


